Dear Mr Corbyn,

This weekend marks the 35th anniversary of the bombing of the Conservative party conference in Brighton.

This was an attack designed to wipe out a Government and strike at the very heart of our democracy.

It was part of a bloody campaign of terror waged by the IRA in Northern Ireland and on the British mainland for more than two decades.

During the Troubles, the IRA claimed the lives of more than 1,700 people, and devastated the lives of countless more.

Communities right across the United Kingdom, from Enniskillen to London and Manchester, are forever scarred and families forever broken by the IRA's murderous attacks.

No amount of time can restore what is lost when a bomb detonates or a bullet is fired.

Many politicians on all sides of the divide have worked tirelessly to secure and sustain peace in Northern Ireland and have unequivocally condemned the IRA's acts of terror during this time.

When asked to condemn the IRA's terror campaign, you refused to do so.

You say you are a man of peace and you want people across the United Kingdom to elect you to lead our country.

The rule of law, not the pursuit of violence, is the foundation of our democracy.

True leadership means putting aside your own prejudices and working for the benefit of all, not advancing the cause of some. The peace in Northern Ireland is built on this principle.

So we urge you now, 35 years on from that direct assault on our democracy, to directly and unequivocally condemn the IRA's murderous attacks.

And we ask you to apologise for a career spent giving succour to violent republicanism when you should have been denouncing it. The first role of a Prime Minister is to keep his people safe, how can you expect people to vote for you if you fail to make this clear?
